**SUBJECT:** Rescission of TEGL No. 25-11

**1. Purpose.** To rescind Training and Employment Guidance Letter (TEGL) No. 25-11, and inform the states that Program Year (PY) 2011 Workforce Investment Act (WIA) Dislocated Worker program funds that were recaptured under WIA Title I Section 132 (c) will not be reallocated.

**2. References.**

- Training and Employment Guidance Letter (TEGL) 26-10, *Workforce Investment Act (WIA) Adult, Dislocated Worker and Youth Activities Program Allotments for Program Year (PY) 2011; Final PY 2011 Allotments for the Wagner-Peyser Act Employment Service Program; and Workforce Information Grants to States Allotments for PY 2011;*
- *TEGL 9-11 Revised Fiscal Year (FY) 2012 "Advance" Funding Levels Available October 2011 for Workforce Investment Act (WIA) Programs and Clarification on the Level of Governor's Reserve;*
- Workforce Investment Act Section 132 (c), P.L. 105-220, 29 U.S.C. 2862 (c); and
- Secretary's Reallotment Procedures, 20 CFR 667.150.

**3. Background.** On April 24, 2012, the Department published TEGL No. 25-11 which provided adjusted PY 2011 funding levels for the WIA Dislocated Worker program that reflected the reallocation of \$251,529 in recaptured funds. Due to statutory limitations on the availability of PY 2011 Dislocated Worker Funds and the time

necessary to administer the recapture and reallocation processes, the Department will not be reallocating the recaptured funds as previously described. Therefore, the Department is rescinding TEGL 25-11 to prevent any confusion related to the availability of these funds.

All States that were subject to recapture of WIA Dislocated Worker funds were notified by the Department and have received revised funding levels. States that were not subject to the recapture are directed to reference TEGL 9-11 Change 1 for final PY 2011 WIA Dislocated Worker funding levels.

4. **Action Required**. States are requested to distribute this information to the appropriate State and local level WIA staff.
5. **Effective Date**. This guidance is effective immediately.
