**SUBJECT:** Employment and Training Administration (ETA) Advisory Checklists Update

1. **Purpose.** To provide a checklist of all currently active ETA advisories as well as a checklist of all ETA advisories rescinded/cancelled since the previously issued checklists.
2. **Action Requested.** Please disseminate this information to appropriate staff.
3. **Summary and Background.**
  - a. Summary – This Training and Employment Notice (TEN) provides a current listing of all active ETA advisories as well as a checklist of all ETA Advisories cancelled by this TEN.
  - b. Background – Training and Employment Guidance Letter (TEGL) 6-01 describes the ETA Advisory system and requires that checklists be issued rescinding/cancelling obsolete advisories and listing those remaining active.

ETA will be reviewing its guidance in accordance with Executive Order 13891, titled “Promoting the Rule of Law Through Improved Agency Guidance Documents” and Office of Management and Budget (OMB) memorandum M-20-02. ETA will inform States, grantees, regulated communities and the interested public of its next steps in implementing the executive order and OMB memo.
4. **Details.** Attachments I through V of this TEN provide the current status of all General Administration Letters (GALs), TEGLs, and Unemployment Compensation Program Letters (UCPLs)/Unemployment Insurance Program Letters (UIPLs), both active and rescinded by this TEN as of the date of this TEN. Those advisories not listed in the attachments have been rescinded/cancelled by previously issued advisories.

Please note:

- The status of the following advisories has been changed to active: UIPL 41-91, UIPL 1-06, UIPL 1-06, Change 1, UIPL 12-08, and UIPL 22-87, Change 2.
- With the rescissions of GAL 4-98 and GAL 5-94, there are no remaining active GALs.
